

# 2010 OPRC Activity and Rally Release

The undersigned participant, OPRC (as defined herein) member and/or participant (hereinafter, collectively, "Participant") may elect to participate in one or more activities and/or competitions ("Activities") under the auspices of the Old People's Riding Club, Inc. and/or the (chapter name) \_\_\_\_\_ of Old People's Riding Club (hereinafter referred to jointly as "OPRC") which may take place prospectively during the calendar year 2010. Dates and locations of these Activities will be determined by the officers of the OPRC and all such dates and locations are intended to be covered by this Release. The Participant does hereby acknowledge, represent, warrant and agree to the following:

1. that the acceptance of participant in the Activity hosted by the OPRC does not constitute a determination of any nature by the OPRC, its affiliates, employees and agents that the Activity is suitable, safe or otherwise appropriate for Participant by reason of Participant's having attained any specific OPRC Rating Level or otherwise, and that OPRC makes no determination, evaluation, representation or warranty to any such effect; and
2. that he or she fully understands the Activity and the jumps, courses and equestrian performances, competitions and activities (mounted and/or unmounted) constituting the Activity, any or all of which may, in fact, be more difficult and different than those constituting the jumps, courses and equestrian performances, competitions and activities (mounted and/or unmounted) used in establishing, testing for and assigning or awarding any OPRC (or any other organization's) Rating Level; and
3. that he or she understands that equestrian activities such as any Activity anticipated for the upcoming year are inherently dangerous and accepts the inherent risks involved therein (including, without limitation, the risk of injury to the Participant and, death and damage or destruction of horses and other property); and
4. that the decision to participate in the Activity, and any evaluation of the participant's ability to safely and competently participate therein, has been made at the sole and absolute discretion of the Participant and Participant accepts complete responsibility for such decision and such participation; and
5. that Participant has read and understands the policies and regulations governing the OPRC participation in activities sponsored or operated by it, and specifically the rules for the Activity and each agrees to abide by such rules, as now in effect, and as amended and in effect from time to time hereinafter; and
6. that Participant understands that failure to adhere to the code of conduct and/or policies and regulations may result in Participant's dismissal from the Activity or other such action as deemed necessary by the officials of the Activity; and
7. that Participant's entry into this Activity constitutes his/her release to be photographed and/or video-taped with such photographs and/or video to be published or broadcast at the discretion of OPRC; and
8. that Participant hereby specifically and knowingly waives, releases and agrees to hold harmless OPRC, any related officers or members of OPRC and/or its affiliated clubs, and any and all landowners, landowners' staff and invitees, lessors and lessees of land or property on which such Activity may take place, from and against any and all claims and causes of action whatsoever, for himself and on behalf of all heirs, assigns, successors, or representatives, which may arise as a result of Participant's participation in the Activity; and
9. that each time that Participant takes part in an Activity during this year, such Participant ratifies and confirms anew each and every point of this Waiver as if Participant had signed this Waiver for the first time immediately prior to engaging in the Activity.
